CASINO WINDSOR CLOSES/REOPENS DUE TO LABOR DISPUTE

On Thursday, April 3, 2014, Caesars Windsor exercised a “planned shutdown” at 6:00 p.m., according to a press release issued by the casino. The shutdown came after negotiations between the casino and Unifor Local 444 did not produce a labor agreement under expected timeframes. A tentative agreement, however, was reached overnight on Thursday allowing the casino to reopen at 9:00 a.m. today.

According to statements made by Unifor Local 444, the union represents over 2,300 workers at Casino Windsor. Both the union and the casino have announced that there is a ratification meeting regarding the tentative agreement that has been scheduled for next Tuesday, April 8, with votes scheduled throughout the day to accommodate various shift workers.

Unifor is a Canadian-based labor organization representing approximately 300,000 private sector workers in various industries, including automotive, hospitality, fishing, energy, and other fields.

BILLS INTRODUCED IN CONGRESS TO AMEND THE FEDERAL WIRE ACT

On March 26, 2014, identical bills entitled the "Restoration of America's Wire Act" were introduced in both the U.S. House of Representative and the Senate. These measures seek to amend provisions of the federal criminal code known as the "Wire Act." Enacted in 1961, the Wire Act currently makes it a federal crime to "knowingly [use] a wire communication facility for the transmission, in interstate or foreign commerce, of bets or wagers or information assisting in the placing of bets or wagers on any sporting event or contest..." 18 U.S.C. 1804. In September, 2011, and in a shift from prior policy, the U.S. Justice Department issued a legal opinion concluding that the "...interstate transmissions of wire communications that do not relate to a 'sporting event or contest' fall outside the reach of the Wire Act."

The current measures, House Resolution (HR) [4301](#) (introduced by Rep. Jason Chaffetz (R-UT)) and Senate Bill [2159](#) (introduced by Sen. Lindsey Graham (R-SC)), state that their aim is to "...restore long-standing United States policy that the Wire Act prohibits all forms of Internet gambling..." These bills would amend 18 U.S.C. 1804 to remove the reference to "sporting event or contest" and instead make the statute applicable to

“any bet or wager.” The bills also explicitly provide that their provisions shall not: (i) preempt any state law prohibiting gambling, or (ii) alter, limit, or extend the relationship between the Interstate Horseracing Act of 1978 and other federal laws currently in effect, the ability of a state licensed lottery retailer to make in-person, computer-generated retail lottery sales, or the relationship between federal laws and state charitable gaming laws.

The practical effect of these amendments would likely serve to ban all forms of internet gambling in the U.S. that would occur across state lines.

These bills are supported by billionaire Sheldon Adelson, the chief executive officer of the Las Vegas Sands Corporation. Mr. Adelson has been an outspoken critic of internet gambling, arguing that it is bad for casinos and for gamblers.

[H.R.4301](#) has been referred to the House Committee on the Judiciary, while [S.2159](#) has been referred to the Senate Committee on the Judiciary.

DEPARTMENT OF DEFENSE AWARDS MGM RESORTS INTERNATIONAL

On April 2, 2014, the U.S. Department of Defense (“DoD”), through its Employer Support for the Guard and Reserve (“ESGR”) office, awarded MGM Resorts International (“MGM”) the Extraordinary Employer Support award during a special ceremony with Nevada Governor Brian Sandoval.

The award—the highest honor bestowed by the ESGR in Nevada—recognizes employers for “sustained support to the Reserve Component of the United States Armed Forces. “

The ESGR seeks to foster a culture in which all employers support and value the employment and military service of members of the National Guard and Reserve in the United States--encouraging employment of Guardsmen and Reservists who bring integrity, global perspective and proven leadership to the civilian workforce—by cooperatively developing mutually beneficial initiatives with employers, recognizing outstanding employer support, creating public

awareness of applicable laws and policies, resolving potential conflicts between employers and their service members, and acting as the employers’ principal advocate within the DoD.

Also individually, MGM’s Executive Vice President and Chief Diversity Officer, Phyllis A. James, received the Patriot Award, which recognizes individual supervisors who provide their Guard- and Reserve-member employees outstanding support.

MGM offers a myriad of programs aimed at providing benefits to military veterans and members of the Guard and Reserve. The programs range from initiatives to provide employment opportunities to veterans as they transition to civilian life, special professional training and networking opportunities for veterans and members of the Guard or Reserve, and a Military Leave of Absence program providing eligible employees with supplemental pay and continued benefits for employees called in to combat during a declared military action.
