HOUSE REGULATORY REFORM COMMITTEE TO HOLD HEARING ON CHARITABLE GAMING BILL

n Wednesday, May 14, 2014, the Michigan House of Representatives Regulatory Reform Standing Committee will conduct a hearing on Senate Bill 878 ("SB 878") at 8:30am in Room 521 of the House Office Building in Lansing. SB 878 is one of ten bills that is on the agenda to be

discussed during the meeting.

On Thursday, April 24, 2014, the Michigan Senate voted 37-0 to approve SB 878 that, if passed into law, would amend the Traxler-McCauley-Law-Bowman Bingo Act ("Bingo Act") to codify changes to the regulatory structure governing charitable Millionaire Party events.

SB 878 was introduced on March 18, 2014 by Senator Rick Jones (R-Allegan County) amidst proposed changes by the Executive Director of the Michigan Gaming Control Board, who oversees Millionaire Party activities. The bill, if passed, would rescind any regulations passed since June 11, 2012 and require the Executive Director to issue new regulations in accordance with the legislation within one year of the bill's effective date.

The legislation would include provisions related to

- The annual licensing of "charitable gaming service providers"
- Event advertising restrictions
- Requirements for locations hosting Millionaire Parties
- Operational requirements
- Compensation of event workers

In addition, the current \$15,000 per event limit on the amount of money handled would be increased to \$20,000 for charities that use a gaming service provider to assist with the event. If the charity operates the event independently, then it may handle up to \$50,000 in funds for each event.

Separately, the Executive Director of the Michigan Gaming Control Board ("MGCB"), which is delegated the authority to oversee Millionaire Party events, submitted amended Administrative Rules to the state in February. UNCLAIMED LOTTERY TICKET ADDS \$100,000 TO SCHOOL AID FUND COFFERS

n Thursday, May 8, 2014, a Fantasy 5 winning ticket with a prize of \$100,000 expired resulting in transmission of the unclaimed amount to the state's School Aid Fund. This marks the fourth major Michigan Lottery prize to go unclaimed since March 10th of this year.

A total of nearly \$739,000— representing two unclaimed \$250,000 Mega Millions winners and two unclaimed Fantasy 5 winners of \$138,727 and \$100,000 respectively—has been added to the School Aid Fund over that period. Tickets for both games are valid for one year from the drawing date.
