## DETROIT CASINOS TEMPORARILY CLOSE DUE TO COVID -19 RESTRICTIONS

All three of Detroit's commercial casinos - MGM Grand Detroit, MotorCity Casino, and Greektown Casino - will be closed through December 8. On November 15, Governor Gretchen Whitmer announced new COVID-19 restrictions during a press conference addressing a recent rise in cases. The Michigan Department of Health and Human Services (MDHHS) issued an <a href="mailto:emergency order">emergency order</a> imposing restrictions on gatherings and requiring face masks. Gatherings are currently prohibited through December 8 at recreational facilities, including Michigan's commercial casinos in Detroit. Rick Kalm, Executive Director of the Michigan Gaming Control Board (MGCB), issued an <a href="mailto:executive order">executive order</a> on November 17 implementing the MDHHS order and ordering the closure of the casinos to the public.

## NORTHVILLE DOWNS CLOSES DUE TO COVID-19 RESTRICTIONS

Rick Kalm, Executive Director of the MGCB, issued an <u>Order</u> closing Michigan's one current horse racing track, Northville Downs, through December 8<sup>th</sup> consistent with the Order issued by the Michigan Department of Health and Human Services.

Northville Downs announced the closure on its website, stating: "We look forward to reopening as soon as we can! Stay safe Michigan!"

## COMMERCIAL GAMING REVENUE REACHES \$9B IN THIRD QUARTER

United States commercial gaming revenue totaled \$9.04 billion in the third quarter, reaching 81% of pre-COVID levels when compared with the third quarter of 2019, according to the American Gaming Association in a press release. Third quarter revenue is up 294% from second quarter's pandemic closures. Gaming revenue is down 36.5% year-over-year in the first nine months of 2020 compared with a 3% decline in the United States' gross domestic product (GDP) during the same period.

"Our industry continues to prioritize the health and safety of our employees, customers, and communities above all else," said AGA President and CEO Bill Miller in the press release. "While these quarterly results are promising, the reality is a full recovery is dependent on continued public health measures to control prevalence rates."

"As state and local officials respond to current COVID-19 outbreaks with additional restrictions, urgent Congressional action to provide COVID-19 relief is even more crucial. Gaming employees and communities depend on it," said Mr. Miller.

More than 100 casinos reopened during the third quarter, making 902 commercial and tribal casinos (90.8% of total) operational by the end of September. At the start of the third quarter in July, 800 casinos (80.8% of total) were operational.

Although slot and table game revenues were down in the third quarter compared with 2019, sports betting revenue bounced back in many new legal betting markets, including Michigan.

As of November 16, the date of the press release, the AGA reported that 911 of 994 United States casinos across 40 states have partially reopened. This includes 442 commercial casinos (94.7% of total) and 469 tribal casinos (89% of total). The AGA's COVID-19 <u>casino</u> <u>tracker</u> shows the reopening status of United States casinos.
