Michigan Internet Gaming and Sports Betting Operators Report Combined \$190.2 Million October Total Gross Receipts

As [reported](#) by the Michigan Gaming Control Board ("MGCB"), Michigan commercial and tribal internet casino gaming and sports betting operators reported a combined \$190.2 million total gross receipts in October. October receipts increased 7.7% when compared to last month's results of \$176.5 million.

October internet gaming gross receipts were \$141 million, an increase of 9.5% from \$128.7 million reported in September 2022. Gross sports receipts totaled \$49.2 million, increasing 2.3% when compared with September's 2022's total of \$47.8 million.

Combined total adjusted gross receipts of \$158.5 million were reported for October, including \$126.7 million from internet gaming and \$31.8 million for internet sports betting. Total monthly internet gaming adjusted gross receipts increased by \$10.9 million or 9.4% and internet sports betting adjusted gross receipts increased by \$ 4.6 million or 16.9% when compared to September 2022.

Compared with October 2021, this month's internet gaming adjusted gross receipts increased 28% or \$27.7 million, and internet sports betting adjusted gross sports betting receipts increased by 577.9% or \$27.1 million.

Total internet sports betting handle was \$480.8 million and rose 31.9% compared with September 2022 results of \$364.5 million.

The operators delivered \$28.2 million in taxes and payments to the State of Michigan during October, with internet gaming taxes and fees contributing

\$26.3 million and internet sports betting taxes and fees contributing \$1.9 million.

The three Detroit Casinos – MotorCity Casino, MGM Grand Detroit, and Greektown Casino – reported city wagering taxes and municipal service fees of \$7.8 million, with internet gaming taxes and fees contributing \$6.9 million and internet sports betting taxes and fees contributing \$852,875 for the month of October.

Tribal operators reported making total payments of \$3 million of wagering payments to the tribes' governing bodies according to the MGCB.

For the first ten months of 2022, aggregate internet gaming adjusted gross receipts totaled \$1.2 billion, and aggregate internet sports betting adjusted gross receipts were \$163.2 million.

During September, one of the tribal operators ceased offering internet gaming, reducing the number of internet gaming operators to 14. A total of 15 commercial and tribal operators offered internet sports betting. Detroit Casinos Report \$102.8 Million October Aggregate Revenue

According to the October [revenues](#) released by the Michigan Gaming Control Board (MGCB), the three Detroit casinos reported \$102.8 million in monthly aggregate revenue in October. Table games and slots generated \$100.7 million in revenue, and retail sports betting generated \$2.1 million in revenue.

The October market shares were:

- MGM, 46%
- MotorCity, 32%

- Hollywood Casino at Greektown, 22%

Monthly revenue for table games and slots declined 9.6% when compared to October 2021 results. October revenue also fell a fraction of 0.1% from September 2022 results. Through October 31, 2022, table games and slot revenue fell 0.3% when compared with the same ten-month period last year.

When compared with October 2021, monthly gaming revenue results were:

- MGM, \$46.4 million, down 11.9%
- MotorCity, \$32.4 million, down 12.3%
- Hollywood Casino at Greektown, \$21.9 million, up 0.3%

The three Detroit casinos paid \$8.2 million in gaming taxes to the State of Michigan, compared to \$9 million for the same period last year. The casinos also reported submitting \$12.4 million in wagering taxes and development agreement payments to the City of Detroit in October.

Retail sports betting qualified adjusted gross receipts (QAGR) for October declined 20.8% when compared with October 2021 results. Monthly QAGR was also down 19.4% from September 2022 results. The Detroit casinos reported total retail sports betting handle of \$23,543,464, and total gross receipts were \$2.1 million.

October QAGR by casino was:

- MGM, \$711,959
- MotorCity, \$680,649
- Hollywood Casino at Greektown, \$702,147

The three Detroit casinos reported submitting taxes on retail sports betting in the amounts of \$79,182 to the State of Michigan and \$96,778 to the City of Detroit during for October 2022.

Year to date thru October 31, aggregate retail sports betting QAGR results were:

- MGM, \$4.7 million
- MotorCity, \$4.3 million

- Hollywood Casino at Greektown, \$6.4 million

Fantasy contest operators reported total adjusted revenues of \$1.5 million and paid taxes of \$126,719 during September 2022.

Fantasy contest operators reported aggregated total adjusted revenues of \$11.2 million and paid taxes of \$944,224 to the state through the first nine months of 2022.
